#### Monitoring status

- TSE sites noise and vibration monitoring ongoing.
- CSM site noise and vibration monitoring ongoing.
- SSJ sites noise and vibration monitoring ongoing.
- NCW sites –movable noise loggers installed in November 2018 for Portion 7 works, real time access now in place.
- Martin Place USP noise and vibration monitoring ongoing.

#### Initiatives

• NCW Portion 7 "noise tent" trial delayed – update awaited.

#### Non-compliance and incident details

Rock hammering was carried out in cross passage 3 (near Marrickville) after 10pm on 27/28
 March and generated a noise complaint from a resident in Lord Street (ref 1004). JHCPBG's
 initial investigation has identified that the mitigation measure of restricting hammering beyond
 10pm (defined in the Tunnelling CNVIS) had not been implemented. Further investigation is
 required to determine whether the noise levels at receivers exceeded the noise management
 level, in which case this represents a non-compliance.

#### Noise and vibration complaints

 Some increase in complaints about ground borne noise and vibration impacts from tunnelling activity. Dealt with appropriately by TSE, including verification monitoring to confirm levels within predictions. • Noise and vibration complaints from all current TSE, CSM, and Northern Corridor Works sites – dealt with appropriately by contractors.

### Ongoing and upcoming environmental risks

- Ongoing ground borne noise and vibration impacts from tunnelling activity.
- Excavation at Martin Place (USP and TSE works).
- Management of noise and from trucks
