Ongoing Issue – Covid-19 pandemic

The NSW government continued with restrictions related to the Covid-19 pandemic situation during November 2020. The Covid Orders relating to construction on Saturdays, Sundays and Public Holidays apply until 25 March 2021.

The AA continues to work with Sydney Metro, DPIE, contractors and the ER to implement appropriate responses to manage these impacts and fulfil the requirements of the Conditions of Approval. In addition to the risks, the Covid-19 situation also continues to present some opportunities, as outlined in previous reports.

- Real-time noise monitors set up 17 November 2020 at Pitt Street south and north by CPB for Pitt Street ISD, with real-time access provided to AA and ER.

Noise and vibration complaints

- Complaint of loud noise from Victoria Cross south OOH being followed up.

Non-compliances, incidents and events

• Noise from Victoria Cross south OOH works (below ground) generated a complaint and was noted in VCISD monitoring; this is being followed up.
