Ongoing Issue – Covid-19 pandemic

The NSW government continued with restrictions related to the Covid-19 pandemic situation during December 2020. The Covid Orders relating to construction on Saturdays, Sundays and Public Holidays apply until 25 March 2021.

The AA continues to work with Sydney Metro, DPIE, contractors and the ER to implement appropriate responses to manage these impacts and fulfil the requirements of the Conditions of Approval. In addition to the risks, the Covid-19 situation also continues to present some opportunities, as outlined in previous reports.
