Ongoing Issue - Covid-19 pandemic

The NSW government continued with restrictions related to the Covid-19 pandemic situation during January 2021. The Covid Orders relating to construction on Saturdays, Sundays and Public Holidays apply until 25 March 2021.

The AA continues to work with Sydney Metro, DPIE, contractors and the ER to implement appropriate responses to manage these impacts and fulfil the requirements of the Conditions of Approval. In addition to the risks, the Covid-19 situation also continues to present some opportunities, as outlined in previous reports.

Noise and vibration complaints

 Noise and vibration complaints from CSM, PSISD, WLISD, VCISD – dealt with appropriately by contractors – see also Non-compliances, incidents and events below.

Non-compliances, incidents and events

- Event noise complaint received 15 January in response to faulty activation of an emergency alarm out of hours at Pitt Street North. Corrective action applied by turning off the alarm as soon as site staff received notification.
- Event noise complaint about sounds of hammering received 16 January during OOH in ground services search at Pitt St North. Incident discussed with team and activities and mitigation measures reviewed. Use of hand tools was approved for the OOH works. Attended noise monitoring will take place during future out-of-hours activities.
- Event high noise activities were noted by the AA prior to 8am 19 January. Activities were being
 managed to achieve the levels in CoA E38. However, consultation as per CoA E37 in relation to
 respite times was ongoing. Corrective action applied by adjusting respite times to exclude high
 noise activities prior to 8am, pending the outcomes of the consultation.
- Event complaint 28 January from a commercial building about high noise during netting
 installation at Victoria Cross south. Corrective action applied by rescheduling works to Saturday
 morning, as requested by building management to mitigate noise impacts. Investigation ongoing
 into whether the event is a non-compliance.

Ongoing and upcoming environmental risks

OOH works at ISD sites through February.
