Ongoing Issue – Covid-19 pandemic

The NSW government continued with restrictions related to the Covid-19 pandemic situation during February 2021. The Covid Orders relating to construction on Saturdays, Sundays and Public Holidays apply until 25 March 2021.

The AA continues to work with Sydney Metro, DPIE, contractors and the ER to implement appropriate responses to manage these impacts and fulfil the requirements of the Conditions of Approval. In addition to the risks, the Covid-19 situation also continues to present some opportunities, as outlined in previous reports.

Non-compliances, incidents and events

- Non-compliance at PSISD for conducting excavation works prior to approval of those works which were included in the Main Works CNVIS. Works were approved to continue conditional on noise and vibration not exceeding the levels in the approved Early Works CNVIS.
- Investigation concluded that event of complaint 28 January was not a non-compliance: respite was being applied.
