FACT SHEET PROPOSED TEMPORARY STORAGE AREA CLYDE | 15 FEBRUARY 2019

Sydney Metro is Australia's biggest public transport project. It will transform Sydney, delivering more trains and faster services for customers across the network.

Sydney Metro City & Southwest extends the new metro network from the end of Sydney Metro Northwest at Chatswood, under Sydney Harbour, through the CBD, and west to Bankstown – a total of 66 kilometres of metro rail.

John Holland CPB Ghella Joint Venture (JHCPBG) has been awarded the contract to build the twin railway tunnels from Chatswood to Sydenham and excavate six new Sydney Metro stations.

Proposed storage area for excavated material – Grand Avenue, Clyde

A temporary storage area is proposed at 10D Grand Avenue, Clyde to stockpile some of the excavated material (spoil) from the Sydney Metro construction sites at Barangaroo and Blues Point. The material is transported by barge to the recently completed marine facility in Clyde, where it is loaded into trucks and reused on other approved projects across Sydney and NSW.

The proposed temporary storage area is required to ensure barges can be fully unloaded and safely depart the facility during high tides. Sometimes the material cannot be immediately taken to other development sites due to timing and / or demand. Some of the material may also be stockpiled for reuse on future local developments in Parramatta and surrounding areas.

Work hours at the site would be 24 hours a day, 7 days a week to align with barge arrivals at the Clyde facility.

Questions and Answers

Where is the proposed temporary storage area?

The proposed temporary storage area is located at 10D Grand Avenue, Clyde. Access to the site is from Grand Avenue.

Why do you need a temporary storage area?

A temporary storage area is required to ensure barges can be fully unloaded and safely depart the Clyde facility during high tides.

How will you transport the material from the Clyde barging facility to the temporary storage area?

A loader will be used to unload material from barges into trucks at the Clyde facility. The trucks will then transport the material to the temporary storage area, where it's unloaded and shaped into a stockpile using an excavator.

What happens to the material after it's stockpiled at the temporary storage area?

Most of the material will be transported by trucks to be reused on other approved developments across Sydney and NSW. Some of the material will remain at the temporary storage area for future local projects in Parramatta and surrounding areas.

What material will be stockpiled at the site?

The stockpiled material will be clean crushed sandstone and/or soil excavated from the Sydney Metro construction sites at Barangaroo and Blues Point. Stockpiles will be stabilised with polymer sprays or covers to minimise dust.

Will there be additional truck movements on Grand Avenue?

There would be no additional truck movements from the estimates provided in the Clyde Barging REF approved by Transport for NSW in early 2018.

What will the work hours be at the site?

Work hours at the site would be 24 hours a day, 7 days a week to align with barge arrivals at the Clyde facility.
