It is anticipated that generally each site will be inspected every second week at this stage of the project. Actions identified during inspections related to parking, bobcat with tonal beeper, ERSED controls; debris/dust management; storage of fuels and chemicals and implementation of monitoring actions required within the CEMP. These actions were assessed as minor to moderate risk and have been closed out during subsequent inspections.

	The Complaint at Crows Nest on 2 September related to out of hours works where construction activities commenced prior to standard construction hours and, emergency works were required after 1pm. The complaint report provided by the TSE contractor nominated the event as comprising non compliance against Condition E47 and additionally, Condition A24(d) as the demolition contractor commenced work prior to receipt of ER endorsement for the CNVIS. The associated

action, a Toolbox on the Crows Nest CNVIS OOHW protocol including emergency procedures that was to be given to workers at Crows Nest has been closed out. It is understood that Sydney Metro communicated this event to DPE.
On 22 September 2017 TSE reported that emergency works were required to complete works at Victoria Cross due to a maintenance issue with a crane. Sydney Metro and the ER were notified and works were completed by 6:30pm. A complaint was received regarding noise and hours of works. TSE noted that works post 6pm were not noisy.
On 26 September a complaint was received in relation to trucks parking outside a Childcare Centre near the Crows Nest site. An update of the complaint report was provided on 4 October that identified the event as a non compliance with the Construction Traffic Management Plan (CTMP) This event has been be recorded as a non-compliance with Project Planning Approval Condition E82. TSE reported it was the truck driver's first day on the Project and he was counselled on requirements and a memo was sent to all drivers accessing Crows Nest to reiterate approved routes.
It is understood that Sydney Metro has been providing summaries of complaints to DPE.
There were no incidents as defined by the project approval definition for incidents reported or observed by the ER during the period or reported to DPE under condition A41.
