Key Construction Activities Look Ahead	
<p>The Construction activities planned for the upcoming period are limited to Advanced Enabling Works (AEW) comprising construction of the Temporary Bus Interchange at the Station St. Carpark (St Mary's) diversion and relocation of services, and establishment of associated road diversions required for future safe operation of the relocated interchange. Therefore, activities for the upcoming period will be consistent with those listed above.</p>	
ER Inspections	
<p>There was one ER Inspection in December 2021 (22/12/2021). The Key points raised during this inspection as follow:</p> <ul style="list-style-type: none"> ▪ TfNSW/Ward to provide Progressive Erosion and Sediment control plan required by the CEMP for Christmas Shutdown Period, and subsequently, for post shutdown works nominating design rainfall event in accordance with the blue book. ▪ Filtered discharge through existing stormwater drainage system to be occur only in cases of overdesign rainfall events until such time as 80% of the site is permanently sealed. ▪ Flammable liquid containers required storage in a bunded area of adequate capacity (110% of largest container) pursuant to the CEMP.
