Noise and vibration issues, incidents, recommendations	
Date	Contract / Location and details
4 February	A resident at Five Dock complained about noise from a street sweeper operating on Second Avenue before 8am on a Saturday. DPE compliance indicated that this is a potential non-compliance with D35 construction hours and requested further information.
20 February	Out of hours (OOH) concrete pour at Westmead (completed by 1850) without OOH permit in place. GLC submitted a non-compliance report on 22 February. Attended noise monitoring indicated that the work was only discernible at times and was likely to be within the NML for the evening period.


Examples of good practice in noise and vibration management	
Date	Contract / Location and details
8 February	Westmead site manager confirmed methodology adopted to minimise (noisy) pile break-back had been successful. It involved over-pouring the concrete and then partially removing poor quality concrete by hand, leaving significantly less material to break-back after the concrete cured.
13 February	The AFJV engineer supervising the OOH works demonstrated consideration for noise impacts on the community by observing and listening to the work from outside the nearest residential premises and taking proactive steps to adjust work methods to reduce noise.

Noise and vibration complaints

21 noise and vibration complaints during February: 2 from Westmead, 1 from North Strathfield, 3 from Burwood, 14 from Five Dock, and 1 from Pyrmont. This is the highest number of monthly noise and vibration complaints to date on this project. 13 of the 14 complaints from Five Dock comprised 2 or more complaints from each of 4 residents close to the eastern shaft site.

Note: The chart shows noise and vibration (NV) complaints in standard hours and out of hours (OOH) periods. Some complaints relate to both time periods so the total number of NV complaints may be less than the sum of standard and OOH complaints.
