Date	Contract / Location and details
1 June	CTP Five Dock. AFJV to develop a procedure around opening and closing shed doors, daytime and OOH. AFJV to investigate whether tonal movement alarm on gantry crane can be replaced and volume turned down. AFJV to complete installation of hoarding at FDK West.
8 June	CTP Five Dock. AFJV report shed vent fans are too loud on north façade. Additional silencers ordered. Burwood North noise and vibration monitor locations to be reviewed and potentially relocated closer to currently potentially most affected residents. Vibration monitor to be reinstated (dislodged when inspected). AFJV to complete installation of hoarding at FDK West (supply chain delays re: galvanising).
28 June	GLC to arrange AA attendance to witness D-wall construction at Parramatta to observe vibration management approach and monitoring.



Noise and vibration complaints
