

# Monthly update – Parramatta

24 January 2025

Sydney Metro is Australia's biggest public transport project.

The NSW Government is delivering Sydney Metro West – a new underground metro railway which will double rail capacity between Parramatta and the Sydney CBD, transforming Sydney for generations to come.

This once-in-a-century infrastructure investment will provide fast, reliable turn-up-and-go metro services with fully accessible stations, link new communities to rail services and support employment growth and housing supply.

Stations have been confirmed at Westmead, Parramatta, Sydney Olympic Park, North Strathfield, Burwood North, Five Dock, The Bays, Pyrmont and Hunter Street in the Sydney CBD. Two potential station locations are being investigated west of Sydney Olympic Park, including one at Rosehill Gardens which could support a significant increase in housing.

Gamuda Australia and Laing O'Rourke Consortium (GLC) has been awarded the contract to deliver nine kilometres of twin metro rail tunnels between Westmead and Sydney Olympic Park, excavation for two new metro stations, a stabling and maintenance facility at Clyde and a precast facility at Eastern Creek.

## Construction activities: February 2025

Tunnelling contractor, GLC will continue major construction at the Parramatta metro station site during February. These activities will be carried out during standard construction hours:

- **Monday to Friday 7am to 6pm and Saturday 8am to 6pm**

Work will involve:

- Archaeological investigations and backfilling of areas once complete.
- Removing concrete sections and piles in stages with saw cutters and jackhammers.
- Delivering and removing machinery, equipment, and materials via George Street.
- Constructing and excavating the station box including rock hammering, concreting, steel bracing installation and support work.
- Ongoing surveying, geotechnical investigations, utility investigations and upgrades within and around site.
- Aerial drone filming on-site. This will be in line with Civil Aviation Safety Authority guidelines.
- Internal cleaning of a heritage building on George Street with small plant and equipment.
- Upgrading and re-lining sewers within Macquarie Lane and United Lane.

## Out-of-hours work

To minimise interruption to local traffic and to ensure the safety of motorists, pedestrians and workers around the site, some work must be undertaken outside standard construction hours.

Out-of-hours work will involve:

- Oversized machinery and equipment deliveries and removal to and from the site between **6pm and 7am from Saturday 1 February to Friday 28 February 2025.**

Out-of-hours activities are in line with Road Occupancy Licences; and Transport for NSW requirements to work in the road corridor and for the movement of oversized vehicles.

## What to expect

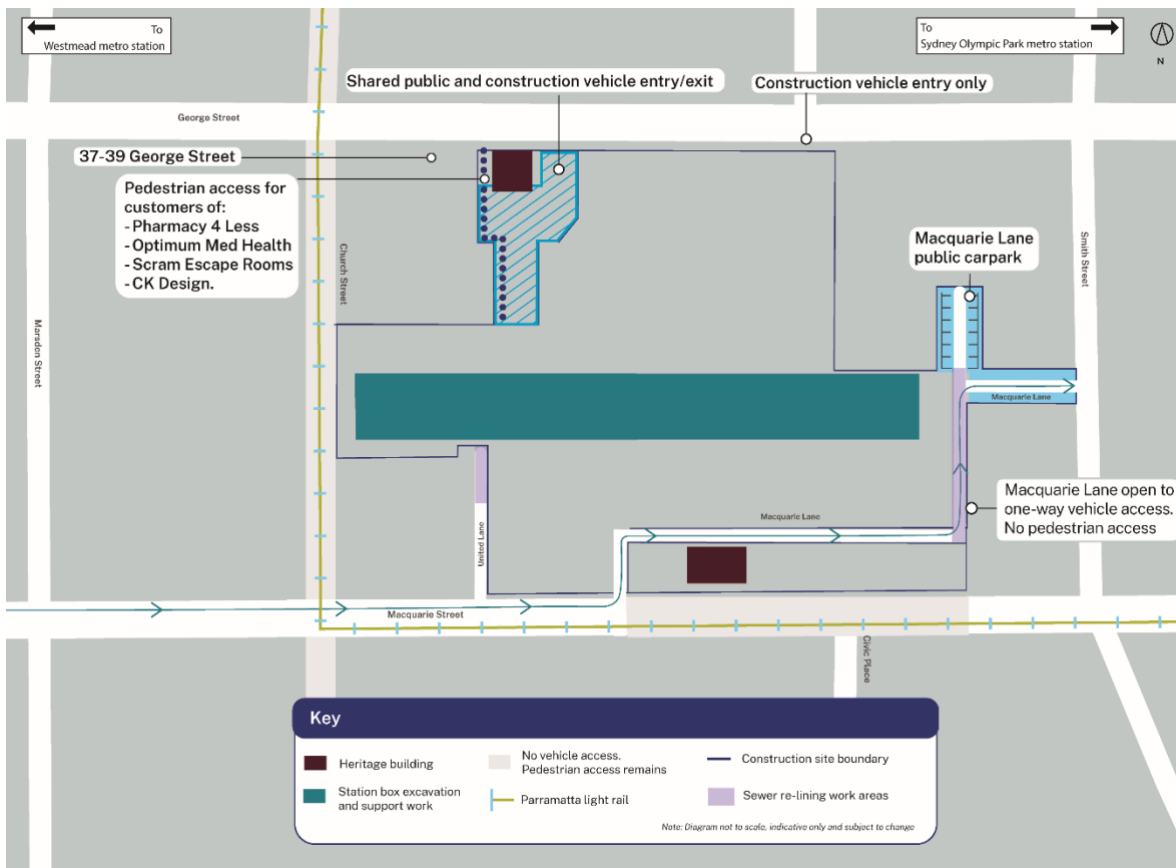
- Some activities will generate noise and vibration, but this will be minimised as much as possible.
- Access to businesses will be maintained unless arrangements are made with you in advance.
- Traffic control will be in place to assist motorists around the work activities on Macquarie Lane and United Lane.

## Changes to traffic, pedestrian and cyclist routes

- Temporary signage and traffic control to assist motorists, pedestrians, and cyclists with changes to traffic conditions. Allow some extra time for your journey when travelling near these areas.

**Equipment used:** Equipment for this work will include but is not limited to hand tools, cranes, generators, truck and dogs, survey equipment, light vehicles, drill rigs, excavators, rock hammer, dozers, vibratory rollers and compactors, concrete agitators, vacuum excavation trucks, tipper trucks, delivery vehicles, fencing, road saw and traffic control devices.
