18/12	Pyrmont East: careful and considerate OOH operation of forklift operating outside shed to move deliveries. Operator avoided excessive revs and also slowed down to carefully navigate ramps, avoiding transient noise from tines rattling or impacting road surface.

- Pyrmont: Cavern excavation continuing 24/7
- Hunter Street: transitioning from demolition to shaft excavation

### CTP:

- Cross passage ground borne noise and vibration. Being managed by door knocking by comms.
- Demob and demolition at Five Dock. Managed by comms notifications and consultation.

## WTP:

• Unwin Street works adjacent to RTA heritage façade. Management measures discussed.
